- THE MINIMUM AGE IS 21 YEARS. IF ASKED, GUESTS MUST SHOW THEIR ID CARD
- GUEST LIST, PRE-SALE, TICKETS OR V.I.P DOES NOT GUARANTEE ENTRY

- GUESTS WHO REFUSE TO SHOW THEIR ID ARE NOT ALLOWED INSIDE
- GUESTS MUST HAVE A WELL-GROOMED APPEARANCE AND MUST BE PROPERLY DRESSED SPORTSWEAR, SPORTS SHOES AND CAPS ARE PROHIBITED.
  - IF A STRICT DRESS CODE APPLIES, IT WILL BE ANNOUNCED ON THE WEBSITE GUESTS MUST ADHERE TO THE DRESS CODE, OTHERWISE ENTRANCE MAY BE DENIED
- IF THE MAXIMUM NUMBER OF GUESTS IS REACHED, NO OTHER GUESTS ARE PERMITTED.
- GUESTS THAT ARE VISIBLY UNDER INFLUENCE OF ALCOHOL / DRUGS OR THAT CAUSE NUISANCE, WILL BE REMOVED FROM THE VENUE OR DENIED ACCESS.
  - GUESTS MUST COOPERATE IN THE BODY SEARCH / FRISKING PROCESS.
    PEOPLE WHO REFUSE TO COOPERATE WILL BE DENIED ENTRANCE TO THE CLUB.
- USE OR POSSESSION OF DRUGS IS STRICTLY PROHIBITED. IF THE USE OR POSSESSION OF DRUGS IS DETECTED, THE GOODS ARE SEIZED, THE GUEST IS REMOVED AND, DEPENDING ON THE QUANTITY, THE POLICE ARE CALLED TO THE SCENE.
- WEAPONS (OR OBJECTS USED AS WEAPONS) ARE PROHIBITED AND ARE CONFISCATED BY SECURITY GUARDS.

  IF THE SERIOUSNESS OF THE SITUATION DEMANDS IT, THE POLICE WILL BE CALLED TO THE SCENE.
  - ACCESS CAN BE PERMANENTLY DENIED TO GUESTS WHO HAVE CAUSED PROBLEMS IN THE (RECENT) PAST.

## **HOUSE RULES**

- IN CASE OF EMERGENCIES, YOU MUST ALWAYS FOLLOW THE INSTRUCTIONS OF OUR STAFF AND SECURITY GUARDS.
  - ALCOHOL IS NOT SERVED TO GUESTS UNDER 18 YEARS OLD.
  - COATS, BAGS AND HELMETS MUST BE DEPOSITED IN THE LOCKERS.
  - IT IS NOT ALLOWED TO TAKE GLASSWARE OR OTHER COMPANY PROPERTIES OUTSIDE.
- GUESTS WHO BEHAVE INAPPROPRIATE OR LOUD WHEN LEAVING THE CLUB, WILL BE DENIED ACCESS IN THE FUTURE.
